Tax refund checks to be picked up at malls

Taxpayers will have the option to pick up their tax refund checks before they're mailed out.

Gov. Eddie Calvo announced yesterday that tax refund checks will be distributed "in the first days of December" at the Micronesia Mall, Guam Premier Outlets and Agana Shopping Center, but the exact dates have yet to be confirmed, according to a press release from the governor's office.

"We need to get this money to the people fast," Calvo stated in the release. "They've waited far too long."

About 91,000 tax refund checks are expected to be released from almost \$200 million the government of Guam borrowed from the bond market.

The government of Guam will receive the bond proceeds at the beginning of next month but because of weekend overlays during the first week of December, there could be a delay in mail deliveries, the press release stated.

Distribution of the checks most likely will occur during the first weekend of the month, the release stated.

The remaining refund checks will be mailed to taxpayers. More information on the distribution time and on which documents residents should bring with them will be announced later.

Another local politician has sent a letter expressing disappointment that President Barack Obama passed through Guam without leaving his plane on Saturday night.

Federal expenditures on Guam exceed \$2B



Federal dollars spent or obligated to projects and personnel on Guam in fiscal 2010 reached \$2.01 billion - surpassing the prior record high of \$1.54 billion in fiscal 2003.

The amount was a part of the Federal Expenditures Report released locally yesterday by the Guam Depart-

ment of Labor. It presents the annual data in a time-series for-



Consolidated report

Gary Hiles, the agency's chief economist, said the data was gleaned from the Consolidated Federal Funds Report, which includes amounts the U.S. gave to Guam, the Commonwealth of Northern Mariana Islands, Marshall Islands, Palau and the Federated States of Micronesia.

Hiles said the dollar figures include pay and benefits for military and federal civilian personnel both active and retired - as well as contracts, procurement of services and various federal grants and

Civilian vs. defense

"Some interesting things that we found this year is that the non-defense expenditures - that's grants

and civilian employees - last /GuamPDN year exceeded the defense expenditures, which was

fairly unusual," Hiles said. "That was because of grants, primarily the (American Recovery and Reinvestment Act) grant, some of which was received in 2009."

He noted that in fiscal 2010, federal dollars sent to Guam for both non-defense and defense spending

"The biggest thing that happened was the huge increase in the contractual category, largely relat-ed to defense," Hiles said.

Food stamp benefits restored

All mistakenly deducted food stamp benefits have been restored, according to the Department of Pub-

lic Health and Social Services. An electronic error at the beginning of the month deducted money from the Supplemental Nutrition Assistance Program accounts of 196 households, said Linda Susuico, chief human services administrator for the agency's Division of Public Welfare.

It took Public Health more than two weeks to fix the error, which may have dramatically affected some families. One woman's account went from \$753 to \$24.50

Because an overall automatic restoration couldn't be done, Public Health started manually restoring accounts late last week

The error involved an automatic deduction system that deducts benefits when a recipient is accidentally overissued, according to Public Health. Due to a processing glitch, automatic deductions were wrongly made to the accounts' food stamp benefit recipients.

Public Health issued certificates for people to take to nonprofits such as The Salvation Army as proof they receive food stamps and were in need of assistance. In a two-day period last week, eight families went to The Salvation Army for food assistance, according to Pacific Daily News

FEDERAL EXPENDITURES REPORT

Key findings

▲ Total reported federal expenditures or obligations on Guam in-creased 44.2 percent, from \$1.39 billion in fiscal year 2009 to \$2.01 billion in fiscal year 2010, the latest year for which complete information on federal expenditures is available.

▲ Federal expenditures or obligations for defense were up 92.6 per-cent and non-defense spending or obligations were up 11 percent (Federal expenditure figures include expenditures and obligations)

▲ Total federal expenditures on Guam increased by 42 percent, from \$1.41 billion in fiscal 2005 to \$2.01 billion in fiscal 2010. Federal expenditure totals had previously remained consistently in the \$1.25 billion to \$1.53 billion range between fiscal 2004 and fiscal 2009.

▲ Using the lower fiscal 2000 level as a base, total federal expenditures on Guam increased by 139 percent from fiscal 2000 to fiscal

▲ The highest level of federal expenditures or obligations on Guam to date was reached in fiscal 2010 substantially surpassing the prior

record high of \$1.54 billion in fiscal

▲ Total direct expenditures or obligations for defense have increased substantially — 127.6 percent — from \$480.1 million in fiscal 1997 to \$1.093 billion in fiscal 2010.

▲ Total direct expenditures or obligations for non-defense activities have increased even more substantially, by 150.7 percent, from \$366.9 million to \$919.8 million.

▲ The largest change from fiscal 2009 to fiscal 2010 was for procurement contracts, which increased \$446.7 million, or 146.5 percent. Salaries and wages increased by 20.5 percent.

▲ Grants: \$449.6 million ▲ Salaries and wages: \$376.6

▲ Retirement and disability pay-ments for individuals: \$294.1 mil-
