when hundreds died in rampaging flash floods, was set off by the season-al monsoon that overflowed major dams and rivers in Manila and surrounding provinces.

The capital and other parts of the country already were saturated from last week's Typhoon Saola, which battered Manila and the north for several days before blowing away Friday. That storm was responsible for at least 53 deaths.



Guam businessman **Dutch Van Dox dead at 80**

THE ORGANIC ACT OF GUAM

An Act to provide a civil government for Guam, and for other purposes

Be it enacted by the Senate and House of Representatives of the United States of America in Congress Assembled, That:

This Act may be cited as the "Organic Act of Guam"

Sec. 2 The territory ceded to the United States in accordance with the provisions of the Treaty of Peace between the United States and Spain, signed at Paris, December 10, 1898, and proclaimed April 11, 1899, and known as the island of Guam in the Marianas Islands, shall continue to be known as Guam

Sec. 3 Guam is hereby declared to be an un incorporated territory of the United states and the capital and seat of government thereof shall be located at the city of Agana, Guam. The government of Guam shall have the powers set forth in this Act and shall have power to sue by such name. The government of Guam shall consist of three branches, executive, legislative, and judicial, and its relations with the federal Government shall be under the general administrative supervision of the head of such civilian department or agency of the Government of the United States as the President may direct

SEC 4 (a) Chapter II of the Nationality Act of 1940, as amended, is hereby further amended by adding at the end thereof the following new

"Sec 206 (a) The following persons, and their children born after April 11, 1899, are hereby declared to be citizens of the United States if they are residing on the date of enactment of this section on the island of Guam or other teritory over which the United States exercises rights of sovereignly:

(1) All inhabitants of the island of Guam on April 11, 1899, including those temporarily abent from the island on that date, who were Spanish subjects, who after that date continued to reside in Guam or other territory over which the United States exercise sovereignty, and who have taken no affirmative steps to pre-serve or acquire foreign nationality

"(2) All persons born in the island of Guam who resided in Guam on April 11, 1899 including those temporarily absent from the island on that date, who after that date continued to reside in Guam, or other territory over which the United States exercises sovereignty, and who have taken no affirmative steps to preserve or ac quire foreign nationality.

"(b) All persons born in the island of Guam on or after April 11, 1899 (whether before or after the date of enactment of this section), subject the jurisdiction of the United States a by declared to be citizens of the United States Provided, That in the case of any person born before the date of enactment of this section, he has taken no affirmative steps to preserve or acquire foreign nationality.

(c) any person hereinbefore described who is a citizen or national of a country other than the United States and desires to retain his present political status shall make, within two years of the date of enactment of this section, a declaration under oath of such desire, said declaration to be in form and executed in the man-ner prescribed by regulations. From and after the making of such a declaration any such person shall be held not to be a national of the united States by virtue of this Act

'(d) The Commissioner of Immigration and Naturalization, with the approval of the Attorney General, is hereby authorized and em powered to make and prescribe such rules and regulations not in conflict with this act as he may deem necessary and proper.

(e) Section 404(c) of this Act shall not apply to persons who acquired citizenship under this

(b) Subsection (a) of section 303 of the Nationality Act of 1940, as amended (8 U.S.C., sec.703), is hereby amended by adding the following new subparagraph:

(5) Guamanian persons and persons Gua-

Sec. 5 (a) No law shall be enacted in Guam respecting an establishment of religion or prohibiting the free exercise thereof, or abridging the freedom of speech, or of the press, or the right of the people peaceably to assemble and to petition the government for a redress of their grievances.

(b) No soldier shall, in time of peace, be quartered in any house, without the consent of the owner, nor in time of war, but in a manner to be prescribed by law.

(c) the right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated; and no warrant for arrest or search shall be issue but upon probable cause, supported by oath or affirmation, and particularly decribing the place to be searched and the person or things to be seized.

(d) No person shall be subject for the same offense to be twice put in jeopardy of punishment; nor shall he be compelled in any criminal case to be a witness against himself.

(e) No person shall be deprived of life, liberty, or property without due process of law

(f) Private property shall not be taken for pub-

lic use without just compensation. (g) In all criminal prosecutions the accused shall have the right to a speedy and public trial: to be informed of the nature and cause of the accusation and to have a copy thereof; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the assistance

(h) Excessive bail shall not be required, nor

excessive fines imposed, nor cruel and unusual punishments inflicted

(i) Neither slavery nor involuntary servitude except as a punishment for crime whereof the party shall have been duly convicted, shall ex-

(i) No bill of attainder, ex post facto law, or law impairing the obligation of contracts shall be enacted.

(k) No person shall be imprisoned for debt. (I) The privilege of the writ of habeas corpus shall not be suspended, unless, when in cases of rebellion or invasion or imminent danger thereof, the public safety shall require it

(m) No qualifications with respect to proper-

ty, income, political opinion, or any other matter apart from citizenship, civil capacity, and residence shall be imposed upon any voter

(n) No discrimination shall be made in Guam

against any person on account of race, language, or religion, nor shall the equal protection of the laws be denied.

(o) No person shall be convicted of treason against the united states unless on the testimony of two witnesses to the same overt act, or on confession in open court.

(p) No public money or property shall ever be appropriated, supplied, donated, or used, direclly or indirectly, for the use, benefit, or support of any sect, church, denomination, sectarian institution, or association, or system of religion, or for the use, benefit, or support of any priest, preacher, minister, or other religious teacher or dignitary as such.

(q) The employment of children under the age of fourteen years in any occupation injurious to health or morals or hazardous to life or limb is hereby prohibited.

(r) There shall be compulsory education for all ildren, between the ages of six and sixteen

(s) No religious test shall ever be required as a qualification to any office or public trust under the government of Guam.

(6) No person who advocates, or who aids or belongs to any party, organization, or association which advocates, the overthrow by force or iolence of the government of Guam or of the United States shall be qualified to hold any public office of trust or profit under the government

THE EXECUTIVE

Section 6(a) The executive authority of the government of Guam shall be vested in an ex-ecutive officer, whose title shall be "Governor of Guam," and shall be exercised under the su-pervision of the head of the department or agency referred to in section 3 of this Act. The Governor shall be appointed by the President by and with the advice and consent of the Senate of the United States, and shall hold his of fice for four years and until his successor is appointed and qualified. The Governor shall be a civilian or a retired officer of the armed forces of the United States. He shall reside in Guam dur ing his incumbency.

(b) The Governor shall have general supervision and control of all executive agencies and instrumentalities of the government of Guam. He shall faithfully executive the laws of the United States applicable to Guam, and the laws of Guam. He may grant pardons and reprieves and remit fines and forfeitures for offenses against the local laws, and may grant respites for all offenses against the applicable laws of the United States until the decision of the President can be ascertained. He may veto any legislation as provided in this Act. He shall commission at officers that he may be authorized to appoint. He may call upon the commanders of the armed forces of the United States in Guam, or summor the posse comitatus, or call out the militia, to prevent or suppress violence, insurrection, or rebellion; and he may, in case of rebellion, invasion, or imminent danger thereof, when the public safety requires it, suspend the privilege of the writ of habeas corpus, or place Guam, or any part thereof, under martial law, until communi cation can be had with the President and the President's decision thereon communicated to the Governor. He shall annually, and at such other times as the President or the Congress may require, make official report of the transactions of the government of Guam to the head of the department or agency designated by the President under section 3 of this Act, and his said annual report shall be transmitted by such de partment or agency to the Congress. He shall perform such additional duties and functions as may, in pursuance of law, be delegated to him the President, or by the department or agency. He shall have the power to issue excutive regulations not in conflict with any ap plicable law. The Governor may submit such recommendations for the enactment of legisla tion to the legislature as he shall consider to be in the people's interest

(c) The Governor shall coordinate and have general cognizance over all activities of a civil nature of the departments, bureaus, and offices of the Government of the United States in Guam

Sec. 7. The President shall appoint a Secre tary of Guam, who shall have all the powers of the Governor in the case of a vacancy in the office of Governor or the disability or temporary absence of the Governor. He shall have custody of the seal of Guam and shall countersign and affix such seal to all executive proclamations and all other executive documents. He shall record and preserve the laws enacted by the legislature. He shall promulgate all proclamations and orders of the Governor and all laws enacted by the legislature. He shall have all such executive powers and perform such other duties as may be prescribed by this Act or assigned to nim by the Governor. He shall hold office for four years and until his successor is appointed

and has qualified

Sec. 8. The head of the department or agency designated by the President under section 3 of this Act may from time to time designate the head of an executive department of the government of Guam or other person to act as Governor in case of a vacancy in the office, or the disability or temporary absence of both the Governor and the Secretary, and the person so designated shall have all the powers of the Governor for so long as such condition continues Sec 9(a) The Governor shall, except as oth-

erwise provided in this Act or the laws of Guam, appoint, by and with the advice and consent of the legislature, all heads of executive agencies and instrumentalities. In making appointments and promotions, preference shall be given to qualified persons of Guamanian ancestry. With a view to insuring the fullest participation by Guarnanians in the government of Guarn, opportunities for higher education and in-service graining facilities shall be provided to qualified persons of Guamanian ancestry. The legislalure shall establish a merit system and, as far as practicable, appointments and promotions shall be made in accordance with such merit

(b) The Governor may appoint or remove any officer whose appointment or removal is not otherwise provided for. All officers shall have such powers and duties as may be conferred or imposed on them by law or by executive regulation of the Governor not inconsistent with any

(c) The Governor shall, from time to time, examine the organization of the executive branch of the government of Guam, and shall determine and carry out such changes therein as are nec essary to promote effective management and to executive faithfully the purposes of this Act and the laws of Guam

(d) All persons holding office in Guam on the date of enactment of this Act may, except as otherwise provided in this Act, continue to hold their respective offices until their successors are ap

THE LEGISLATURE

Sec. 10. The legislative power of Guam, except as otherwise provided in this Act, shall be vested in a legislature which shall consist of a single house of not to exceed twenty-one mempers to be elected at large. General elections to the legislature shall be held on the Tuesday next after the first Monday in November, bien nially in even-numbered years. The members of the legislature holding office on the date of en-actment of this Act shall continue to serve as such until the next election held in accordance with the laws of Guam and until their successors have duly qualified. The legislature in all respects shall be organized and shall sit according to the laws of Guam in force on the date of enactment of this Act and as amended or modified after such date.

Sec. 11. The legislative power of Guam shall extend to all subjects of legislation of local application not inconsistent with the provisions of this Act and the laws of the United States applicable to Guam. Taxes and assessments on property, internal revenues, sales, license fees, and royalties for franchises, privileges, and con-cessions may be imposed for purposes of the government of Guam as may be uniformly pro-vided by the Legislature of Guam, and when necessary to anticipate taxes and revenues bonds and other obligations may be issued by the government of Guam, Provided, hower That no public indebtedness of Guam shall be authorized of allowed in excess of 10 per centum of the aggregate tax valuation of the property in Guam. Bonds or other obligations of the government of Guam payable solely from revenues derived from any public improvement or undertaking shall not be considered public debtedness of Guarn within the meaning of this section. All bonds issued by the government Guam or by it authority shall be exempt, as to principal and interest, from taxation by the Gov-ernment of the United States or by the government of Guam, or by any State or Territory or any political subdivision thereof, or by the District of Columbia

Sec. 12. The legislature shall be the judge of the selection and qualification of its own mem-bers. It shall choose from its members its own officers, determine its rules and procedure, not inconsistent with this Act, and keep a journal,

Sect. 13(a) The members of the legislature shall, in all cases except treason, felony, or breach of the peace, be privileged from arrest during their attendance at the legislature and in going to and returning from the same

(b) No member of the legislature shall be held to answer before any tribunal other than the egislature itself for any speech or debate in the legislature

Sec. 14. Every member of the legislature and all officers of the government of Guam shall take the following oath or affirmation:

"I solemnly swear (or affirm) in the presence of Almighty God that I will well and faithfully support the Constitution of the United States, the laws of the United States applicable to Guam and the laws of Guam, and that I will conscientiously and impartially discharge my duties as a member of the Guam Legislature (or as an officer of the government of Guam)."

Sec 15 No member of the legislature shall, during the term for which he was elected or during the year following the expiration of such term, be appointed to any office which has been created, or the salary or emoluments of which have been increased during such term.

Sec. 16 No person shall sit in the legislature who is not a citizen of the United States, who has not attained the age of twenty-five years and who has not been domiciled in Guarn for at

least five years immediately preceding the sitting of the legislature in which he seeks to qualify as a member, or who has been convicted of a felony or of a crime involving moral turpitude and has not received a pardon restoring his civil rights.

Sec 17 Vacancies occurring in the legislature shall be filled as the legislature shall provide, except that no person filling a vacancy shall hold office longer than for the remainder of the term for which his predecessor was elected

Sec. 18. Regular sessions of the legislature shall be held annually for a period or periods not to exceed in the aggregate sixty calendar days, as the legislature may determine. Such ses sions shall convene in Agana on the second Monday in January. The Governor may convene the legislature in special session at such time and place as he may deem it necessary but no special session shall continue longer than fourteen days, and no legislation shall be considered at such session other than that specified in the call therefor or in any special message by the Governor to the legislature while in such session. All sessions of the legislature shall be open to the public. Sec. 19. Every bill passed by the legislature

shall, before it becomes a law, be entered upon the journal and presented to the Governor. If he approves it, he shall sign it, but if not he shall except as hereinafter provided, return it, with his objections, to the legislature within ten days (Sundays excepted) after it shall have been presented to him. If he does not return it within such period, it shall be a law in like manner as if he had signed it, unless the legislature by adjournment prevents its return, in which case it shall be a law if signed by the Governor within thirty days after it shall have been presented to him; otherwise it shall not be a law. When a bill is returned by the Governor to the legislature with his objections, the legislature shall enter his objections at large on its journal and proceed to reconsider it. If, after such reconsideration, two-thirds of the legislature agree to pass it, it shall be sent to the Governor. If he then approves it, he shall sign it; if not, he shall within ten days transmit it to the President of the United States if the President of the United States approves it, he shall sign it. If he shall not approve it, he shall return it to the Governor so stating, and it shall not be a law. If he neither approves it nor disapproves it within ninety days from the date of transmittal to him by the Governor, it shall be a law, in like manner as if he had signed it. If any bill presented to the Governor contains several items of appropriation of money, he may object to one or more of such items, or any part or parts, portion or portions thereof, while approving the other items, parts or portions of the bill. In such a case he shall append to the bill, at the time of signing it, a statement of the items, or parts or portions thereof, to which he objects, and the items, or parts or portions thereof, while ap-proving the other items, parts, or portions of the bill. In such a case he shall append to the bill, at the time of signing it, a statement of the items, or parts or portions thereof, to which he objects and the items, or parts or portions thereof, as objected to shall not take effect. All laws enacted the legislature shall be reported by the Governor to the head of the department or agency designated by the President under section 3 of this Act, and by him to the Congress of the United States, which reserves the power and authority to annul the same. If any such law is not annulled by the Congress of the United States within one year of the date of its receipt by that body, it shall be deemed to have been approved. Sec. 20 (a) Appropriations, except as other-

wise provided in this Act, and except such appropriations as shall be made from time to time by the Congress of the United States, shall be made by the legislature.

(b) If at the termination of any fiscal year the slature shall have failed to pass appropriation bills providing for payments of the necessary current expenses of the government and meeting its legal obligations for the ensuing fiscal year, then the several sums appropriated in the last appropriation bills for the objects and purposes therein specified, so far as the same may be applicable, shall be deemed to be reappropriated, item by item.

(c) All appropriations made prior to the date of enactment of this Act shall be available to the government of Guam.

Sec. 21. The legislature or any person or group of persons in Guam shall have the unrestricted right of petition. It shall be the duty of all officers of the government to receive and without delay to act upon or forward, as the case ay require, any su-THE JUDICIARY such petition

Sec. 22(a) There is hereby created a court of record to be designated the "District Court of Guam," and the judicial authority of Guam shall be vested in the District Court of Guam and in such court or courts as may have been or may hereafter be established by the laws of Guam. The District Court of Guam shall have in all causes arising under the laws of the United States, the jurisdiction of a district court of the United States as such court is defined in section 451 of title 28. United States Code, and shall have original jurisdiction in all other causes in Guam, jurisdiction over which has not been transferred by the legislature to other court or courts established by it, and shall have such appellate jurisdiction as the legislature may determine. The jurisdiction of and the procedure the courts of Guam other than the District Court of Guarn shall be prescribed by the laws

(b) The rules heretofore or hereafter promul gated and made effective by the Supreme Court of the United States pursuant to section 2072

or title 28, United States Code, in civil cases section 2073 of title 28, United States Code, in admiralty cases; sections 3771 and 3772 of tille 18, United States Code, in criminal cases; and section 30 of the Bankruptcy Acts of July 1 1898, as amended (title 11, U.S.C. sec 53), in bankruptcy cases; shall apply to the District Court of Guam and to appeals there from Sec. 23(a) The United States Court of Ap-

peals for the Ninth Circuit shall have jurisdiction of appeals from all final decisions of the District Court of Guam in all cases involving the Constitution, laws, or treaties of the United States stitution, laws, or treaties of the United States or any authority exercised thereunder, in all habeas corpus proceedings, and in all other civil cases where the value in controversy exceeds \$5,000, exclusive of interest and costs. civil cases where the value in controversy exceeds \$5,000, exclusive of interest and costs.

(b) Any party may appeal to the Supreme Court of the United States from an interlocutory or final judgment, or order of the District Court of Guam, holding an Act of Congress unconstitutional in any civil action suit, or proceeding to which the United States or any of its agencies or any officer or employee thereof, as such officer or employee, is a party. A party who has received notice of appeal under this section shall take any subsequent appeal or cross appeal to the Supreme Court. All appeals or cross appeals taken to other courts prior to such notice shall be treated as taken directly to the Supreme Court

Sec. 24(a) The President shall, by and with the advice and consent of the Senate, appoint a judge for the District Court of Guam who shall hold office for the term of four years and until his successor is chosen and qualified unless sooner removed by the President for cause. The judge shall receive a salary payable by the United States which shall be the same as the salary of the Governor of Guarn as provided by section 26(a) of this Act, and shall be entitled to the benefits of retirement provided in section 373 of title 28, United States Code. The Chief Justice of the United States may, with the consent of the judge as assigned, assign any United States circuit or district judge to serve as a judge in the District Court of Guam whenever it is made to appear that such an assignment is necessary for the proper dispatch of the business of the court.

(b) The President shall appoint by and with the advice and consent of the Senate, a United States attorney and United States marshal for Guarn to whose offices the provisions of chapters 31 and 33 of title 28, United States Code, respectively, shall apply

(c) The provisions of chapters 21, 41, 43, 49, and 57 of litle 28, United States Code, shall apply to the District Court of Guam.

MISCELLANEOUS

Sec. 25(a) The laws of Guam in force on the date of enactment of this Act, except as amended by this Act, are hereby continued in force, subject to modification or repeal by the Congress of the United States or the Legislature of Guam, and all laws of Guam inconsistent with the provisions of this Act are hereby repealed to

the extend of such inconsistency.

(b) Except as otherwise provided in this Act, no law of the United States hereafter enacted shall have any force or effect within Guarn unless specifically made applicable by Act of the Congress either by reference to Guam by name or by reference to "possessions." The President of the United States shall appoint a commission of seven persons, at least three of whom shall be residents of Guam, to survey the field of Federal statutes and to make recommendations to the Congress of the United States with-in twelve months after the date of enactment of this Act as to which statutes of the United States not applicable to Guam on such date shall be made applicable to Guam, and as to which statutes of the United States applicable to Guam

on such date shall be declared inapplicable. Sec. 26(a) The Governor shall receive an annual salary at the rate provided for Governors of Territories and possessions in the Executive Pay Act of 1949, but not to exceed \$13,125, to be paid by the United States: Provided, That if the Governor shall be a retired officer of the armed forces of the United States the pay which he shall receive as Governor shall be his pay and allowances as such officer plus such sum as will total the equivalent of the compensation for a civilian Governor.
(b) The Secretary of Guam shall receive an

annual salary to be paid by the United States at a rate established in accordance with the standards provided in the Classification Act of 1949.

(c) All officers and employees of the government of Guam shall, if their homes be outside Guam, be entitled to transportation at the expense of the United States for themselves, their mmediate families, and their household effects from their homes to Guam upon their appointment and from Guarn to their homes upon completion of their duties: Provided. That such transportation other than that incident to initial appointment shall not be required to be furnished s they shall have served in Guarn for a least two years, unless separated for reasons beyond their control. They shall accrue leave in accordance with the Leave Act of the United States, and once during every two years shall be entitled to transportation at the expense of the United States for themselves and their immediate families from Guam to their homes and return. For purposes of transportation tot heir homes and return, they shall be allowed travel time not in excess of thirty days without charge against annual leave and during such travel time they shall be paid their salaries as prescribed by this Act or the laws of Guam Trans portation shall be by the shortest and most

First lady named in lawsuit

Doctor seeks \$8M from Gutierrez, Family Violence Task Force

A Navy commander is suing first lady Geri Gutierrez for \$8 million for defamation of character, after she allegedly wrote a letter questioning his expertise as a psychiatrist.

The civil lawsuit was filed June 23 in Superior Court by Dr. William J. Hocter, a Navy commander, licensed forensic psychiatrist and medical doctor, and by his wife, Annette Hocter, against Gutierrez and the Family Violence Task Force. The suit cites statements Gutierrez wrote in a letter to Capt. Jerald Ulmer,

Naval Hospital commanding officer, on behalf of the task force, court documents said.

The letter was written in January after Dr. Hocter, who also is employed at the Pacific Area Counseling Network, testified as an expert witness in the Osmundo Sangalang murder trial, court documents said.

Osmundo Sangalang was convicted in February for the July 1999 shooting deaths of his wife, Elaine Sangalang, and her friend, Jun Cabana Velasco.

Dr. Hocter took the witness stand and reported his results of a forensic psychiatric evaluation on Osmundo Sangalang. Dr. Hoctor said

the two victims provoked Sangalang to shoot them because the "victims' behavior drove (Osmundo Sangalang) crazy," court documents said.

Gutierrez's letter, according to court documents, said, "Comments made by Dr. Hocter in his report to the

Cell phone firm files for bankruptcy

One of Guam's cellular telephone companies filed for bankruptcy protection, and court documents state the company's largest debt is to Guam Telephone Authority, which is owed more than \$1 million.

Futuristic Systems, which resells cellular service provided by the government-run telephone authority, filed for Chapter 11 bankruptcy June 30, documents state.

But the company might come out of Chapter 11 soon, if it can resolve contract disagreements with the telephone
