FIRST CONSTITUTIONAL CONVENTION
OF THE TERRITORY OF GUAM

Minutes of the Thirtieth General Session

The Thirtieth General Session of the First Constitutional Convention of the Territory of Guam convened at Convention Headquarters at 7:15 p.m., April 20, 1970. Mr. Antonio M. Palomo, President of the First Constitutional Convention, presided.

PRAYER

The Chaplain offered the following prayer:

"In the Name of the Father and of the Son and of the Holy Spirit. Amen. Let us Pray ...
O God of mercy and love, hear the prayers of a grateful people and accept our humble act of thanksgiving for the safety you have given to the three astronauts. You have blessed our country enriching it with a wealth of natural resources; more, you have blessed its people with that capability of working together that the country, although made up of diverse cultures and ideas, may continue to assure its people of their inherent rights to live freely. Because of these blessings, O Divine Creator, we as a nation have managed to unravelled not only the mysteries that surround us, but even those that are beyond us. Lord, sustain all of us with your gracious favor that we may bear the burden and responsibilities of making proper use of what you have given us. You gave us the world, our environment to husband according to our needs. You gave us the world that we may master it in your Name. We pray you to assist us in our efforts to master it, but deliver us from the pollution of difficulties and problems that are really not in it but of our own machinations. Amen.

PRIVILEGE OF THE FLOOR

Mrs. Betty S. Guerrero expressed her views on Proposition Nos. 1 and 6-A in view of the fact she was not present when they were given second reading and placed on the order of third reading. She urged the Convention to consider introducing a proposition to give the legislature the power to enact laws concerning the abuse of marihuana and other mind-altering drugs. She also urged that Proposition No. 6-A be amended further.

Mr. Francisco R. Santos stated that a bill to protect the public health and safety by amending the narcotic, depressant, stimulant and hallucinogenic drug laws as passed by the United States Senate is being entertained by the House of Representatives.

Mr. Santos stated that Guam is included in the definition of "state". (Refer to Senate Bill 3246, page 11, line 17. of the Ninety-First Congress, first session).

Proposition No. 33, introduced by Francisco Aguon -

A PROPOSITION TO AMEND SECTION 8 OF THE ORGANIC ACT OF GUAM, CREATING THE OFFICE OF SECRETARY OF GUAM AND HAVING HIM NEXT IN LINE TO THE LIEUTENANT GOVERNOR IN THE CASE OF EXECUTIVE VACANCIES.

Proposition No. 34, introduced by Francisco Aguon -

A PROPOSITION TO ADD SUBSECTION (x) TO SECTION 5 OF THE ORGANIC ACT OF GUAM TO GUARANTEE THE RIGHT TO TRIAL BY JURY.

Proposition No. 35, introduced by Francisco Aguon -

A PROPOSITION TO ADD A NEW SUBSECTION (a) TO SECTION 5 OF THE ORGANIC ACT OF GUAM AND TO RENUMBER THE EXISTING SUBSECTIONS (a) THROUGH (u) TO (b) TO (v) INCLUSIVELY TO INCLUDE THE RIGHTS OF MAN AMONG GUAM'S BILL OF RIGHTS.

Proposition No. 36, introduced by Joaquin G. Blaz, Chairman of the Taxation and Finance Committee -

A PROPOSITION TO ADD SECTION 11-A TO THE ORGANIC ACT OF GUAM TO CLARIFY THE RIGHT OF THE LEGISLATURE TO TAX ALCOHOLIC BEVERAGES CONSUMED IN GUAM.

Proposition No. 37, introduced by Jose L. Ceneda -

A PROPOSITION TO ADD SUBSECTION (c) TO SECTION 29 OF THE ORGANIC ACT OF GUAM TO REQUIRE THE LEGISLATURE TO TAKE ACTION TO AFFIRMATIVELY PROTECT THE LIVES AND PROPERTIES OF THE PEOPLE OF GUAM.

Proposition No. 38, introduced by Joseph F. Ada -

A PROPOSITION TO AMEND SUBSECTION (p) OF SECTION 5 OF THE ORGANIC ACT OF GUAM TO SPECIFICALLY AUTHORIZE THE LEGISLATURE TO EXTEND ASSISTANCE TO THOSE SCHOOL CHILDREN ATTENDING PRIVATE SCHOOLS IN GUAM.

Proposition No. 39, introduced by Joe Nededog -

A PROPOSITION TO AMEND SECTION 2 OF THE ORGANIC ACT OF GUAM TO INCLUDE WITHIN THE JURISDICTION OF THE TERRITORY OF GUAM THE SUBMERGED LANDS SURROUNDING THE ISLAND.

Proposition No. 40, introduced by Gregorio M. Borja -

A PROPOSITION TO AMEND SECTION 18 OF THE ORGANIC ACT OF GUAM TO PERMIT THE LEGISLATURE TO CALL SPECIAL SESSIONS.

Proposition No. 41, introduced by Gregorio M. Borja -

A PROPOSITION TO ADD SUBSECTION (v) TO SECTION 5 OF THE ORGANIC ACT OF GUAM TO GUARANTEE PRIMARY ELECTION FOR ALL TERRITORIAL ELECTIVE OFFICES.

Proposition No. 42, introduced by Joseph F. Ada -

A PROPOSITION TO ADD A NEW SUBSECTION (v) TO SECTION 5 OF THE ORGANIC ACT OF GUAM TO GUARANTEE TO THE PEOPLE OF GUAM THE RIGHT TO ORGANIZE AND BARGAIN COLLECTIVELY.

Proposition No. 43, introduced by Joseph F. Ada -

A PROPOSITION TO REPEAL AND REENACT SUBSECTION (f) OF SECTION 5 OF THE ORGANIC ACT OF GUAM TO STRENGTHEN AND CLARIFY THE RIGHTS OF THE PEOPLE TO JUST COMPENSATION IN CASE OF CONDEMNATION.

Proposition No. 44, introduced by Joe Nededog -

A PROPOSITION TO AMEND SUBSECTION (b) OF SECTION 5 OF THE ORGANIC ACT OF GUAM TO PROTECT THE PEOPLE OF GUAM FROM MILITARY ACTIVITIES THE DANGEROUS NATURE DURING TIMES OF PEACE.

Proposition No. 45, introduced by Joaquin G. Blaz, Chairman of the Taxation and Finance Committee -

A PROPOSITION TO AMEND SUBSECTION (a) OF SECTION 31 OF THE ORGANIC ACT OF GUAM TO ELIMINATE THE 30% WITHHOLDING REQUIREMENT ON PASSIVE INCOME PAYMENTS TO AMERICAN CITIZENS AND CORPORATIONS NOT RESIDING IN GUAM.

Proposition No. 46, introduced by Joaquin G. Blaz, Chairman of the Taxation and Finance Committee -

A PROPOSITION TO ADD SUBSECTION (i) TO SECTION 31 OF THE ORGANIC ACT OF GUAM TO PROHIBIT THE REBATE OF THE TERRITORIAL INCOME TAX.

Proposition No. 47, introduced by Jose L. Ceneda -

A PROPOSITION TO AMEND THE FIRST PARAGRAPH OF SECTION 6 OF THE ORGANIC ACT OF GUAM TO AUTHORIZE THE ELECTION OF GOVERNOR AND LIEUTENANT GOVERNOR BY PLURALITY VOTE SO LONG AS THE SUCCESSFUL CANDIDATES RECEIVES TEN PER CENT MORE VOTES THAN THE NEXT HIGHEST.

Proposition No. 48, introduced by Joseph F. Ada -

A PROPOSITION TO AMEND SUBSECTION (m) OF SECTION 5 OF THE ORGANIC ACT OF GUAM TO PERMIT FELONS DISCHARGED FROM JAIL TO VOTE IN TERRITORIAL ELECTIONS.

A PROPOSITION TO AMEND SUBSECTION (c) OF SECTION 5 OF THE ORGANIC ACT OF GUAM TO GUARANTEE THE RIGHT OF THE PEOPLE OF GUAM AGAINST UNREASONABLE INVASIONS OF PRIVACY.

Proposition No. 51, introduced by Frank G. Lujan, Francisco R. Santos-

A PROPOSITION CONCERNING THE RIGHT OF JURY TRIAL IN CIVIL AND CRIMINAL.

Proposition No. 53, introduced by Francisco B. Aguon, Chairman of the Gubernatorial Powers Committee -

A PROPOSITION TO AMEND SECTION 6 OF THE ORGANIC ACT OF GUAM TO CREATE THE OFFICE OF SECRETARY OF GUAM, AND FOR OTHER PURPOSES.

REPORTS OF COMMITTEES

Mr. Joseph F. Ada, Chairman of the Bill of Rights Committee, reported-out Proposition Nos. 10 and 19 favorably, a substitute proposition for Proposition No. 13, Proposition No. 15 tabled for further research and Proposition No. 24 was given to the Convention Counsel for further breakdown.

Mr. Joseph F. Ada moved to place Proposition No. 29 on the order of second reading. Seconded.

Mr. President put the question whether the Convention would agree to the advancement of said proposition and it was determined in the affirmative, by unanimous consent.

By direction of the President, the Administrative Secretary read a letter from the Chairman of the Education Committee, reporting-out Proposition 12 and 17 as amended, and recommending that Proposition No. 14 be placed in the inactive file.

Mr. Franklin J. Quituqua moved to place Proposition Nos. 12 and 17 on the order of second reading. Seconded.

Mr. President put the question whether the Convention would agree to the advancement of said propositions and it was determined in the affirmative, by unanimous consent.

Mr. Francisco R. Santos moved to place Proposition Nos. 30 and 21 on the order of second reading. Seconded.

Mr. President put the question whether the Convention would agree to the advancement of said propositions and it was determined in the affirmative, by unanimous consent.

Mr. Francisco B. Aguon moved to place Proposition Nos. 33 and 32 on the order of second reading. Seconded.

Mr. President put the question whether the Convention would agree to the advancement of said propositions and it was determined in the affirmative, by unanimous consent.

Mr. Pedro A.E. Manibusan, Chairman of the Committee on Manpower Development, presented his report to the Chairman of the Executive Council, Mr. Joe T. San Agustin.

By direction of the President, the Administrative Secretary read letters from the Style and Drafting Committee reporting-out Proposition Nos. 3, 10 and 28 without change, and Proposition No. 6-P in revised form.

PROPOSITIONS ON SECOND READING

Mr. Adrian C. Sanchez moved to place Proposition No. 26 on the order of third reading. Seconded.

Debate held thereon.

Mr. Joseph F. Ada moved to amend Proposition No. 26 as follows:

Page 1, line 8, strike out the word "territory" and insert the word "government".

No second - motion defeated.

Mrs. Betty S. Guerrero moved to amend Proposition No. 26 as follows:

Page 1, line 8, restore the word "government", after the word "government" insert the words "of the". Motion seconded.

Mr. Francisco R. Santos moved to amend Proposition No. 26 as follows:

Page 1, line 9, strike out the comma at end of the line and insert a period.

Page 1, line 10, before the word "shall" insert the words "The government of the territory". Motion seconded.

Discussion held thereon.

Mr. Francisco R. Santos moved to refer Proposition No. 26 back to the Political Status Committee and be placed on the first order of business at the next meeting. Second.

Mr. President put the question whether the Convention would agree to said motion and it was determined in the affirmative, a majority of the delegates elected to the Convention and present voting in favor thereof.

Ordered, That Proposition No. 26 be referred back to the Political Status Committee and placed on the first order of business at the next meeting.

By direction of the President, the Administrative Secretary gave Propositions Nos. 29, 12, 17, 33, 21, 31 and 32 second reading.

Proposition No. 20 *

Mr. Adrian C. Sanchez moved to place Proposition No. 20 in the inactive file. Seconded.

Debate held thereon.

Mr. Joseph F. Ada moved to refer Proposition No. 20 back to the Political Status Committee. Seconded.

Debate held on Mr. Ada's motion.

Mr. President put the question whether the Convention would agree to Mr. Ada's motion and it was determined in the affirmative, a majority of the delegates elected to the Convention and present voting in favor thereof.

Ordered, That Proposition No. 20 be referred back to the Political Status Committee.

Proposition No. 29 -

Mr. Joseph F. Ada moved to place Proposition No. 29 on the order of third reading. Seconded.

Debate held thereon.

Mr. President put the question whether the Convention would agree to said motion and it was determined in the affirmative, a majority of the delegates elected to the Convention and present voting in favor thereof.

Ordered, That Proposition No. 29 be submitted to the Style and Drafting Committee and placed on the order of third reading.

Mr. Francisco B. Aguon moved to suspend the rules to consider Proposition No. 3 for final passage, then return to the order of business. Seconded.

Mr. President put the question whether the Convention would agree to said motion and it was determined in the affirmative, by unanimous consent.

Proposition No. 3 - (Third reading)

By direction of the President, the Administrative Secretary gave Proposition No. 3 third reading.

Mr. President put the question whether the Convention would agree to the final passage of Proposition No. 3 and it was determined in the negative, a majority of the delegates elected to the Convention and present not voting in favor thereof.

Mr. Joseph F. Ada moved that Proposition Nos. 12 and 11 be referred back to a joint-committee of Public Health and Social Services and Education. Seconded.

Discussion held thereon.

Mr. Francisco R. Santos moved to amend Mr. Ada's motion to include Proposition Nos. 14 and 17. Seconded.

Mr. President put the question whether the Convention would agree to Mr. Ada's motion as amended and it was determined in the affirmative, a majority of the delegates elected to the Convention and present voting in favor thereof.

Ordered, That Proposition Nos. 11, 12, 14 and 17 be referred to the joint-committee of Public Health and Social Services and Education, and a report to be made at the next regular session.

PROPOSITIONS ON SECOND READING

Proposition No. 30 -

Mr. Joseph F. Ada moved to refer Proposition No. 30 back to the Legislative Powers Committee for proper wording. Seconded.

Mr. President put the question whether the Convention would agree to said motion and it was determined in the affirmative.

Ordered, That Proposition No. 30 be referred to the Legislative Powers for rewording.

Proposition No. 21 -

Mr. Francisco R. Santos moved that Proposition No. 21 be placed on the order of third reading. Seconded.

Debate held thereon.

Mr. Joaquin G. Blaz moved to amend said proposition as follows:

Page 1, line 11, strike out the word "fourteen" and insert the word "eleven".

Motion seconded and discussion held thereon.

Mr. Francisco R. Santos moved that Proposition No. 21 be tabled and put on the first order of business at the next session. Seconded.

Mr. President put the question whether the Convention would agree to Mr. Santos' motion and it was determined in the affirmative.


